PARTICIPATION AGREEMENT, RELEASE, WAIVER, INDEMNIFICATION, AND ASSUMPTION OF RISK

In consideration of the services and efforts of the U.S. Department of the Interior, Bureau of Land Management, Colorado Plateau Mountain Bike Trail Association (COPMOBA), their officers, agents, representatives, employees, members of COPMOBA, and all other persons or entities associated with COPMOBA regarding its **Wild West End Tour** event, (hereinafter referred to as Releasees), I, the undersigned, acknowledge and agree as follows:

Although Releasees have taken reasonable steps to provide me with what is needed to enjoy an activity for which I may or may not be skilled, I understand that this activity is not without risk. I understand that certain risks cannot be eliminated without destroying the unique character of this activity. I also understand that the same elements which contribute to the unique character of this activity can because of loss of or damage to my equipment, accidental injury or illness, or, in extreme cases, permanent trauma or death. I understand the inherent risks of this event may include, but are not limited to, the following:

Falling, collision, upset, striking obstructions or other person(s), dangerous trail conditions, unsafe speed of travel for conditions, unmarked natural and unnatural trail hazards, head injuries, equipment failure, actions of other participants and/or support personnel, weather conditions including temperature, exposure, (hypothermia, sunstroke, sunburn, heat exhaustion), dehydration, getting lost, highway or roadway vehicles, and off road vehicles.

I am aware that mountain biking and related activities entail risks of injury or death to myself. I understand that this description of these risks is not complete and that other unknown or unanticipated risks may result in loss, injury or death. I agree to assume all responsibility for the risks identified herein and those risks not specifically identified. My participation in this activity is purely voluntary, no one is forcing me to participate, and I elect to participate in spite of the risks.

I certify that I am fully capable of participating in this activity. Therefore, I assume full responsibility for myself, and my minor children, for bodily injury, death, and loss of personal property and expenses thereof as a result of those inherent risks and dangers and/or also of my negligence and/or assumption of risk in participating in this activity.

I have read, understood, and accepted the terms and conditions stated herein and acknowledge that this agreement shall be effective and binding upon myself, my heirs, personal representatives, successors, assigns, estate and for all members of my family, including any minors accompanying me or participating on their own. I acknowledge I am not relying on any oral, written or visual representation of statements made by Releasees including those made in its brochures or other promotional material, to induce me to participate in this activity.

In exchange for the consideration set forth above, and in acceptance of my registration to participate in the Wild West End Tour, I hereby, for myself, my heirs, personal representatives, successors, my assigns and my insurance carriers, and any and all other taking by or through me, release, indemnify and agree to hold harmless Releasees, from any and all demands, claims, actions, causes of action, (including, but not limited to, negligence and breach of contract), judgments and decrees whatsoever, and any and all other legal redress I might have,

including all costs and attorneys' fees, of any kind, that might arise out of my participation in the Wild West End Tour which may include the risks listed above and/or those which are not listed above but which otherwise might be involved. I represent that my physical condition and biking skills, as well as my equipment, are to the best of my knowledge, adequate to allow me to safely participate in the tour and no medical professional or other person has advised me against participation in such an event. I agree to adhere to all the rules and to act reasonably. I understand that an ANSI or SNELL approved helmet must be worn while riding on the tour. I understand and agree that COPMOBA, acting through its representatives overseeing the Wild West End Tour event, exercising their sole discretion on behalf of COPMOBA, may require that I ride in a sag vehicle in lieu of riding some or all sections if due to lack of riding fitness, ability or skills, or for any other reason, I am unable to keep up with the main group and thereby adversely affecting the tour operator's rendezvous schedule, the guides' availability to assist other riders in the group or the experience for other riders. I further agree that I will never, at any time during the event, ride my bicycle ahead of that rider designated by said representatives as the lead rider. I further agree that violation of any obligation assumed by me under this agreement will result in termination of all my rights and privileges under this agreement, and of any and all responsibilities owed to me by COPMOBA and said representatives in connection with the event.

I FULLY UNDERSTAND THAT THIS IS A BINDING AGREEMENT AND THAT BY SIGNING BELOW I AM RELEASING RELEASEES FROM ALL POSSIBLE LIABILITY WHATSOEVER AND THAT I AM WAIVING FOR MYSELF AND ALL OTHERS WHOSE RIGHTS ARE BASED ON MY OWN ANY AND ALL PAST, PRESENT OR FUTURE DAMAGES OR INJURIES. BY SIGNING BELOW, I ACKNOWLEDGE THAT I AM 18 YEARS OF AGE OR OLDER, AND IF NOT, I RECOGNIZE THAT A LEGAL GUARDIAN MUST SIGN AS WELL.
